Three Policies of Fukuoka University Graduate School of Law

Admission Policy (Policy of Accepting Admissions)

OPublic Law major

We accept students who would fit one of the following requirements for the public law major.

◆Master's course

- 1. Those who have fundamental academic skills in legal or political science, complete master's thesis on one of the individual subjects in special field of the public law, and are willing to go on to a doctoral course in the future.
- 2. Those who are deeply interested in legal and political practices, and are studying one of the individual themes in special field of the public law, and are willing to take the exams of public servants and various qualification exams in the future.
- 3.As students who have a job, those who are deeply interested in individual subjects in special field of public law, and are willing to complete master's thesis as one result of the recurrent study.
- 4. As foreign students, those who are deeply concerned with the laws and politics of their home country and are willing to study Japanese law and politics from the viewpoint of international comparison.

◆Doctoral course

- 1. Those who have the ability to complete the doctoral dissertation by promoting research on their own, possessing advanced academic skills, acquiring necessary foreign languages for special subjects of the public law.
- 2.As students who have a job, those who possess deep knowledge of practical skills and advanced academic skills, specialized subjects of the public law major, have the ability to study on their own, complete the doctoral dissertation.
- 3. As foreign students, those who have the ability to research on individual themes in special fields of the public law, from the viewpoint of international comparison between their home country and Japan, to study on their own and complete the doctoral dissertation.

OCivil and Criminal Law major

We accept students who would fit one of the following requirements for the civil and criminal

law major.

◆Master's course

- 1. Those who have fundamental academic skills in legal science, complete master's thesis on one of the individual subjects in special field of the civil and criminal law, and are willing to go on to a doctoral course in the future.
- 2. Those who are deeply interested in legal practices, and are studying one of the individual themes in special field on the civil and criminal law, and are willing to take the exams of public servants and various qualification exams in the future.
- 3.As students who have a job, those who are deeply interested in individual subjects in special field of civil and criminal law, and are willing to complete master's thesis as one result of the recurrent study.
- 4.As foreign students, those who are deeply concerned with the laws of their home country and are willing to study Japanese law from the viewpoint of international comparison.

◆Doctoral course

- 1. Those who have the ability to complete the doctoral dissertation by promoting research on their own, possessing advanced academic skills, acquiring necessary foreign languages for special subjects of the civil and criminal law.
- 2.As students who have a job, those who possess deep knowledge of practical skills and advanced academic skills, specialized subjects of the public law major, have the ability to study on their own, complete the doctoral dissertation.
- 3.As foreign students, those who have the ability to research on individual themes in special fields of the civil and criminal law, from the viewpoint of international comparison between their home country and Japan, to study on their own and complete the doctoral dissertation.

Curriculum Policy (Curriculum Formation and Implementation Policy)

OPublic Law major

For the public law major, students take the following items according to the systematically organized curriculum.
